Instructions:

I know and understand that participating in an outdoor activity is a potentially hazardous activity. I hereby represent and certify that I am in good health and in a physical condition to participate in this event. I certify that I have either been fully vaccinated against Covid 19 or if not, that I understand and take full responsibility for the health risks related to attending the event while unvaccinated. If while on site I give any false information about my health status, I understand I will be asked to leave the gathering immediately and may not be able to attend future events.

I assume all risks associated with the event and acknowledge that it carries with it the potential for property loss, serious injury, or death. I understand the risks include, but are not limited to, those caused by terrain, falls, contact with other participants, lack of hydration, traffic, obstacles, fire, weather, bee stings or tick bites, actions of other people including, but not limited to, participants, volunteers, spectators, event officials and event monitors, and/or administrators of the event. All such and related risks are known and appreciated by me.

I understand that SpiritFire is committed to creation of a safe space for fire circle ritual and community; any form of harassment, discrimination, or inappropriate behaviors towards others while on the mountain will result in expulsion and possibly legal action. If I am aware of issues of harassment, I know I can and should approach a staff member to receive assistance.

I agree to obey all pertinent laws and event policies while participating in the event. In the case of an emergency or other issues affecting the community, I also agree to immediately adhere to directions given me by event officials as well as law enforcement and emergency personnel.

I do hereby fully release and forever discharge The Abode or it's staff, as well as SpiritFire and it's director, volunteers, and its partners from any and all claims for injuries, illnesses, damages, expenses or loss that me or my minor child may suffer arising out of, connected with, or in any way associated with the event, program or activities. I have read and fully understand the above information warning of risk, assumption of risk, waiver and release of claims. If any event is canceled for any reason due to circumstances beyond reasonable control, The Abode, SpiritFire, and affiliated partners have no obligation to refund my entry fee or any other costs and/or expenses I incurred. This waiver is a legally binding agreement and will be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.
